# Procedures for Allocation of Areas of Timor-Leste Territory for Upstream Activities

By means of Decree No. 7/2019, of 27 September 2019, the Government approved the procedure for the allocation of areas of Timor-Leste territory to petroleum exploration and production activities. The member of the Government responsible for the supervision of petroleum activities is responsible for the definition, allocation and exclusion of areas for these activities.

# Reservation in Favor of TIMOR GAP, E.P. in the Upcoming Oil and Gas Licensing Round

Government Resolution No. 27/2019, of 2 October 2019, reserves for TIMOR GAP a maximum 20% participating interest in each production sharing contract to be concluded as a result of the upcoming oil and gas licensing round.

### Approval of Aircraft Leasing Regime

Ministerial Diploma No. 55/2019, of 30 October 2019, approves the new rules applicable to leasing of aircrafts. The diploma is approved following the recent adoption of a Civil Aviation National Policy for Timor-Leste which is to be implemented until 2030. The statute sets forth the conditions for the approval of the operation of aircrafts to be used in air transportation, leased between national operators and between national and foreign operators.
