#### BY-LAWS OF LUANDA OIL INDUSTRY WORKERS UNION APPROVED

Order No. 475/16, of 18 October 2016, approved the by-laws of the Luanda Oil Industry Workers Union (Sindicato dos Trabalhadores da Indústria Petrolífera e Afins de Luanda - "STIPAL"). The Order confirms the conclusion of STIPAL's incorporation process, as well as its legal capacity to operate as a union in the Luanda Province.

Executive Decree No. 435/16, of 31 October 2016, set the characteristics of the circulation stamp and the amount of the Road Traffic Fee for year 2016.

### NEW RULES FOR CIVIL AVIATION

Presidential Decree No. 216/16, of 26 October 2016, created the Schedule Committee and approved the Regulations on Procedures for the Allocation of Slots for Regular Operations of Airlines Operating at Airports and Airfields of the Country. Presidential Decree No. 217/16, of 31 October 2016, further approved the Regulations on Access to and Exercise of Air Transport Activity. These Presidential Decrees entered into force on the date of their publication.

# TECHNICAL UNIT FOR MONITORING OF PROJECTS WITH FOREIGN FINANCING CREATED

Presidential Decree No. 213/16, of 5 October 2016, approved the creation of the Technical Unit for Project Monitoring with Foreign Financing ("UTAP"). UTAP is a technical support service of the Ministerial Departments in charge of the preparation of awarding and negotiation of works contracts and service contracts which are financed by external credit lines. UTAP operates under the coordination of the Minister of Finance.

## AMENDMENT TO THE 2016 STATE BUDGET

Law No. 28/15, of 31 December 2015, which approves the 2016 State Budget, was amended by Law No. 19/16, of 24 October 2016. This law entered into force on the date of its publication.
